Mayor Naughton called the Regular Meeting of the Mayor and Council of the Borough of Spring Lake to order at 7:00 P.M. with a moment of silent prayer. She then proceeded with the Pledge of Allegiance to the Flag. The Mayor announced that the meeting is being held in accordance with the Open Public Meetings.

Workshop Discussion

Mayor Naughton reported that Mr. Nick Sapnar, the Chairman of the Planning Board, is in attendance to present a few items that have been under consideration by the Planning Board. The Mayor thanked Mr. Sapnar for his presence and gave him the floor.

Mr. Sapnar introduced the first item, generator pads, stating that currently a homeowner is required to present to the Planning Board when their plans meet or exceed impervious coverage. A generator pad, Mr. Sapnar stated, is approximately 15 square feet which would result in roughly .2% coverage in the R-2 zone and about .1% coverage in an R-1 lot. It's the feeling of the Planning Board, Mr. Sapnar stated, that if a resident presented to the Board they would likely be granted the variance for the generator. So, if it's an existing property, the Board would not require the resident to show the impervious coverage, stated Mr. Sapnar. This, Mr. Sapnar added, was discussed with the Planning Board's attorney, Mr. George McGill, who suggested that it be excluded all together. In summary, Mr. Sapnar stated that as long as the pad was 15 square feet or less, they would be exempt from the impervious coverage requirements. The Mayor asked if the Board has been presented with a lot of applications for generators. Mr. Sapnar responded that there have been many, but that many residents have been discouraged in making application citing the expense of presenting to the Planning Board outweighs the actual cost of the generator. Mr. Sapnar went on to compare the Borough's process to Brielle's process which looks primarily at setback requirements and does not have to meet impervious coverage requirements. Mr. Jordan inquired as to the required material for the pads. Mr. Sapnar stated that they can be stone or concrete.

The second item is related to garages, stated Mr. Sapnar. Mr. Sapnar gave a brief overview noting that garage coverage changed from 5% to 500 square feet in the R-2 zone and 600 square feet in the R-1 zone. Mr. Sapnar stated that it is their feeling that for a detached garage it would make sense to allow for a 500 square foot garage or 5%, whichever is larger, but not more than 750 square feet in all three zones. Mayor Naughton asked what prompted the Board to re-evaluate this. Mr. Sapnar reflected on various applications requesting larger garages on smaller lots and/or larger lots who are limited to smaller garages. Mr. Jordan asked about the height limitations. Mr. Sapnar stated that the height limitation stays the same at 18 feet from grade. Mr. Sapnar also stated that the setback requirements remain the same and the garage remains a part of the impervious coverage consideration.

Finally, Mr. Sapnar stated that the last item is the actual lot coverage. Currently, the R-1 zone is set at 40% coverage, R-2 is 55% and R-3 is 45%, stated Mr. Sapnar. The Board is recommending changing the R-2 coverage to 50%. The Mayor asked when the last time the lot coverage was modified in any way in the R-2 zone. Mr. Colao started that it likely goes back as far as 2002. The Mayor thanked Mr. Sapnar noting that the Council will not be making any decisions or recommendations tonight given the absence of two (2) council members. Mr. Lyle Marlow, 110 Pennsylvania, asked for clarification on the garage size minimums. Mr. Sapnar responded. Mr. Marlowe voiced that he felt the recommendations were reasonable; however, he felt the 18 foot height allowance is too high. Ms. Elsie Dubac, 415 St. Clair Avenue, stated that she put in a generator and asked about the position of the generator relative to the house. Mayor Naughton responded that this issue was previously addressed and tonight's recommended changes deal with the allowance of a generator pad but does not affect other factors, such as location.

Council Comments & Staff Reports

Mr. Frost publicly thanked Police Chief Kerr and Borough Administrator Dempsey for their efforts in getting Spring Lake opened and readied for skating for the first time in many years. Mr. Frost stated that he's heard many positive comments.

Mr. Jordan reminded everyone that residents have until midnight on Sunday, February 16, 2014 to purchase their lockers or beach boxes after such time sponsored nonresidents may purchase lockers and beach boxes. Mr. Jordan also reported, in connection with the proposed reduction to the speed limit on Third Avenue, that there is a need for a traffic study.

Mayor Naughton reported that Mr. Bill Wingard, a long-term Spring Lake resident who has been very involved in Veteran's affairs and serves as the Master of Ceremonies for the Borough's Memorial Day event, wants to gift to Spring Lake another monument at Veteran's Park commemorating the raising of the flag at Iwo Jima. Mr. Wingard expressed his feelings that this may be the last generation that has any familiarity with the Second World War and it's an opportunity to preserve the memory of the sacrifices made in connection with this event. Mayor Naughton stated that Mr. Wingard shared a sketch of the proposed monument adding that Mr. Wingard is prepared to incur the full cost of the project. Mayor Naughton voiced her support for the effort and recommended that the Council accept this generous gift.

Mr. Avakian reported that he is still awaiting a response from the Department of Transportation on the pending grant application. Also, Mr. Avakian stated that there is a meeting in February with the US Fish and Wildlife service and other state agencies in connection with the bypass pipe at Wreck Pond. Mr. Lyle Marlowe asked if the meeting was in connection with design or funding. Mayor Naughton stated that it's a bit of both and involves a long agenda to determine which parties are responsible for what

parts of the project. The Borough is responsible for detailing their thoughts on what the Borough can contribute to the project, stated the Mayor, as well as contacting the County to assess if the project may qualify for open space monies. Mr. Marlowe expressed concern about the funding. Mayor Naughton spoke to some ideas that have been discussed over the years noting that it's important for the Borough to "have some skin in the game" and demonstrate to others who may potentially contribute that the Borough is also heavily invested. One source, Mayor Naughton stated, is to potentially sell some property the Borough owns which borders Black Creek and use the revenue to help pay for the project. There are three (3) buildable lots in the area, the Mayor stated, and it's always been the feeling that it's an asset in that part of town that should be sold to purchase another asset as opposed to just selling it to pay some bills. The pipe in that part of town seems to be an ideal asset to purchase that would benefit the residents in the same area of town, added the Mayor. This, the Mayor stated, may be a creative way to come up with \$1 to \$1.5 million to dedicate to the project. As such, the Mayor stated, they have asked Borough Administrator Dempsey to get an appraisal of the properties so they can understand what a sale like this may bring in. Mr. Marlowe also suggested that the Borough be in touch with Spring Lake Heights who will also benefit from the pipe. The Mayor agreed and added that they will also be in touch with the Borough's legislators, County representatives, DEP and other organizations that may be able to assist with the funding.

Mr. Dempsey reported on Resolution 14-035 stating that it's a resolution authorizing the filing of an application with the NJ DEP and Environmental Infrastructure Trust for improvements to various sanitary sewer and stormwater repairs. Mr. Avakian added that the funding is already allocated and it's quite likely that the application and funding will be approved. The Mayor asked how long the application process takes. Mr. Dempsey reported that the application must be filed by March, 2014 and they anticipate the work to begin in the fall of 2014.
