**Proclamations, Presentations & Special Guests**

**R-14-083 – Introduction of 2014 Municipal Budget**

Mayor Naughton reported that this is a very collaborative effort involving the Finance Committee, CFO Robbin Kirk, Borough Administrator Bryan Dempsey along with the various department heads. The Mayor stated that tonight's business represents the formal introduction of the budget which typically results in limited discussion. The Mayor noted that a public hearing will take place in four weeks allowing time for council members to review and discuss the details of the budget. The Mayor also pointed out that this year's budget does include a five (5) year capital roads project which has been requested by many residents and several council members feel strongly about. The Mayor added that the CFO will speak to this project tonight and will also discuss it at the public hearing in four weeks. Mr. Frost also will address this project during the Council Comments portion of the meeting. The Mayor invited CFO Robbin Kirk to speak.

Ms. Kirk reported that the public hearing is set for June 10, 2014 and stated that the copies of the budget being introduced will be made available for the public in the Municipal Clerk's office. Ms. Kirk noted that \$830,000 that is being committed toward a road program. A portion of this will come from a \$.01 tax increase with the rest being accumulated through reductions in other line items, stated Ms. Kirk. Ms. Kirk also reported that there is a resolution on the agenda proposing a water/sewer rate increase. Ms. Kirk stated that although the operating costs have not changed drastically, but the billings, or overall consumption, has been down the last three (3) years. The Borough has not had a rate increase since 2010 so it's actually working out to be about a one and one-half percent increase over five (5) years, stated Ms. Kirk.

**Council Comments & Staff Reports**

Mayor Naughton opened her remarks recognizing the passing of Ms. Eleanor Twomey stating that she is an amazing example of how to grow old in a graceful, strong and intelligent way. Mayor Naughton stated that Ms. Twomey has a wonderful and generous spirit which she personal was the recipient of. The Mayor reflected on how Ms. Twomey may have been quick to disagree with the Council but that she was just as quick to offer her genuine and heartfelt praise. Mayor Naughton, while noting the empty seat normally occupied by Ms. Twomey, stated that it’s hard to believe she won’t be present at future meetings. The Mayor publically voice appreciation for the many years that Ms. Twomey kept the Council on task and her commitment to the Spring Lake community.

Mayor Naughton continued reminding the audience of the Memorial Day Parade and Ceremony scheduled for Memorial Day Monday. The Mayor acknowledged Mr. Bill Wingard’s efforts in coordinating the event noting that it’s a wonderful and meaningful ceremony reminding us all of the importance and true meaning of Memorial Day. Also, the Mayor reported, Mr. Wingard was recently honored as Citizen of the Year and publically congratulated him on this honor.

Mayor Naughton extended congratulations to the BID on the Fashion Weekend event noting that the banners approved by Council looked great. The Mayor stated that the banners have been replaced with hanging flowers that will look beautiful this summer. Regarding the DOT grant for Ludlow Avenue road repairs, Mayor Naughton reported that the Borough did not get the grant and has learned that the Borough may apply for LAIF (Local Aid Infrastructure Funding). The Borough is going to make application for this funding which would be in addition to the dollars earmarked in the budget for the roads project. Mayor Naughton presented photos of the sluice gates being installed at Wreck Pond stating that this is a project that’s been many years in the making. A meeting will take place this week with US Fish and Wildlife in connection with the second pipe for Wreck Pond, stated the Mayor. In addition, the council has the support of all three (3) towns, Wall Township, Sea Girt and Spring Lake Heights on the application for the open space grant which will be used to fund a portion of the project. Finally, Mayor Naughton publically thanked the Borough staff in connection with their efforts in the badges sales and distribution.

Mr. Erbe stated that he looks forward to the public hearing on the budget stating that they worked hard and are anxious to hear the public’s response.

Mr. Erbe also stated that Ms. Twomey will be greatly missed noting that she has been an influence on his life since High School reflecting on her role as a monitor to him while a member of the Catholic Youth Organization. Mr. Erbe acknowledged her tireless involvement expressing that she was an incredibly warm and caring citizen of Spring Lake. Mr. Erbe stated that he believes that one of the things that she would most like to be remembered for is how much she cared for Spring Lake.

Mr. Fay stated that he is also looking forward to the budget.

Mr. Judge, responding to a resident's request for decibel readings on the Pennsylvania Avenue pump station, reported that the readings average between the mid to upper sixties noting that this was prior to the installation of the attenuation devices. They expect the decibel readings to be reduced by about 25% with the devices. Mr. Judge expressed his thanks to the finance committee and Ms. Kirk for their hard work associated with the budget and encouraged the other council members to review it carefully and look for any other cost saving and/or revenue opportunities. Mr. Judge also acknowledged the passing of Ms. Twomey and recognized her great contribution to Spring Lake through her questions and keeping council members, past and present, on their toes.

Mr. Frost thanked Ms. Kirk and the Finance Committee for their efforts in connection with the budget and expressed excitement about the capital being put aside for a comprehensive road program. Mr. Frost stated that he had brought in Rutgers Center for Advanced Infrastructure and Transportation Group that is an engineering group that assesses road conditions and offers ideas for road renovation and preservation. Mr. Frost suggested the Borough consider a proposal from this group to help determine the best way to address the roads problem in the Borough and stated that he looks forward to working with Mr. Avakian on the project.

Mr. Jordan stated that he too would like to acknowledge Ms. Twomey's passing and fondly reminisced on Ms. Twomey's explanation on the difference between bonds and notes when he first became a council member as well as her pointing to Borough Attorney Colao stating "Action?" when he announced an Executive Session. Mr. Jordan stated that she will be missed.

Mr. Jordan expressed appreciation for the kind words in connection with the budget preparation noting that they did work hard and welcome any and all feedback particularly as it pertains to the water and sewer budget.

Regarding the beach season being right around the corner, Mr. Jordan reported that there is some last minute curb and sidewalk work being done at the north end and that there are still some lockers available for purchase.

Mr. Avakian reported that the sluice gates, weather permitting, will be installed later this week and thanked Mr. Dempsey for his continued efforts working with the endangered species habitat. Mr. Avakian further reported that they will be meeting with US Fish and Wildlife in hopes of getting the project on the right track. Mr. Avakian expressed disappointment in not being awarded the DOT grant for Ludlow Avenue.

Mrs. Venables stated that she feels strongly that the Council should acknowledge the opening of the North End Pavilion by way of a short ribbon cutting ceremony and suggested Thursday, May 22<sup>nd</sup> at 6:00 pm. Mrs. Venables added that she hoped to invite the members of the Pools and Pavilion Committee and other strong supporters including both current and former Council members as well as the general public. Mr. Judge added that he supports the idea noting that it's a great moment for Spring Lake and proposed that there also be a raffle to draw a winning name of who gets to jump in the pool first. The Mayor asked how we get the word out. It was suggested that the Coast Star assist and the use of the Facebook and Twitter. The Mayor asked if a vote was needed. Mr. Dempsey stated that no vote was necessary and there was an informal showing of hands in support.

Mrs. Venables continued acknowledging Ms. Twomey's passing stating that she was a friend and was always motivated by good heart and good intention. Ms. Twomey was a great service to the public through her participation and reporting of council meeting activities and she will be missed, stated Mrs. Venables.

Mr. Dempsey stated that the Mount Laurel house is moving along with the roof being put in place tomorrow noting that by August 15<sup>th</sup> it may have occupants. Mayor Naughton asked about the deadline for the application process. Mr. Dempsey stated that the applications are all in and the selection will be made mid-July or early August.

The Mayor asked if Mr. Dempsey would report on Lake Como. Mr. Dempsey stated that they will be using a camera provided by the County to view the pipe from the outfall structure and toward the ocean. A hundred foot section of the pipe was repaired prior to the beach replenishment and there is now a large section of the pipe that has been cracked, stated Mr. Dempsey. The Mayor stated that the pipe is draining. Mr. Dempsey confirmed this stating that even with the last significant storm where the water came close to overflowing they were prepared to start pumps if needed but they were able to monitor it closely and the pumps were not needed. Mr. Judge thanked Mr. Dempsey for his efforts.

Mr. Judge asked Mr. Colao if there could be a short Executive Session, with no action being taken, regarding the Lake Como pipe.

**PUBLIC HEARING NOW OPEN**

Mayor Naughton offered a brief summary of the ordinance noting that it addresses specifically how a road needs to be repaired when it's been opened for water, sewer, gas or other like reasons. It was the collective thought of the council to ensure that the Borough's roads are repaired in such a way that the repair lasts for several years versus what's been done in the past.

Mr. Jordan asked for clarification in connection with the minimum requirements on either side of the excavation site. Mr. Avakian responded citing the standards typically used but noting that with the use of the infrared technology the strips of replaced pavement that has resulted in the past will be far less visible. The Mayor added that with the infrared repair, the trench or strip will be there but will be far more superior. Mr. Frost inquired as to whether any of the information from the Rutger's study was able to be incorporated into this ordinance. Mr. Avakian responded that the ordinance is fairly comprehensive already but points from the study may be included when they address full width road restoration.

Mrs. Venables asked for clarification of the residents' responsibility versus the Borough's. Mr. Dempsey responded that the residents will be responsible for paying for the street opening permit and then the Borough will coordinate the scheduling of the contractors to create economies of scale.

Mrs. Venables asked if there's a need to edit the ordinance to better clarify the residents role. The Mayor asked if through the permit procedure will the roles of the resident and Borough be obvious and therefore not need to be detailed in the ordinance. Mr. Dempsey voiced confidence that the administrative process is sufficient to clarify the roles and is not needed in the ordinance.

Mayor Naughton gave a brief overview noting that the adopting of this ordinance will effectively ban smoking along the length of the boardwalk as well as the entranceways around the pavilions.

Mr. Frost reflected on Mr. Erbe's previous comments on the topic and that although he agrees with the beach and boardwalk portion of the ban he feels there is a need for a place for smokers to go. Mr. Frost offered that there are areas north of both the north and south pavilions as well as the pier beach parking lot that could be equipped with ashtray receptacles near the bike racks. Mr. Frost reiterated his support for the ordinance but expressed an interest to provide smokers an alternative.

Mr. Erbe voiced agreement with Mr. Frost's suggestions noting that the ordinance does not need to address it but the Borough should offer a place for people to smoke.

Mr. Judge acknowledged the validity of Mr. Frost's and Mr. Erbe's points but feels strongly that a complete ban is needed. Mr. Judge referenced Belmar's move from a roped off section of the beach for smoking to a complete ban and stated that Spring Lake's ban should be no less restrictive than the neighboring community.

Mr. Frost offered that every entrance to the boardwalk in Belmar has a smoking receptacle and anyone walking to the boardwalk must pass people smoking at the entrance. Unlike Belmar, Mr. Frost continued, Spring Lake has areas that could be used for smokers.

Mrs. Venables pointed out that according the ordinance, people can smoke in the locations identified by Mr. Frost. Mr. Frost acknowledged this but suggested we go a step further by designated the areas and providing receptacles so that cigarette butts are not just thrown on the ground.

Mr. Jordan suggested the council adopt the ordinance as is and then have the Beach Committee review the designated area issue separately.

Mr. Erbe requested some assurance from the Beach Committee that it would be addressed. Mr. Judge offered that assurance. Mr. Frost and Mr. Erbe agreed this was a good solution.

Harry Zarb, 2205 Third Avenue, stated that his position that smoking is bad and that he did not want to walk by anyone smoking and would oppose the council taking any action to make it more comfortable for people who smoke.

Frank Suozzi, 112 Brown Avenue, suggested that the smokers could walk back to their cars. Mr. Erbe stated that although he's not taking the smoker's side on the issue he does feel there is a litter issue that needs to be addressed and the need to provide some level of comfort for a person paying \$10 to visit the beach.

**Public Comments**

Frank Suozzi, 112 Brown Avenue, on behalf of all the residents in the Wreck Pond flood zone expressed thanks to the Mayor, the council, Mr. Avakian and Mr. Dempsey for the arrival of the sluice gates and expressed hope that the this step will be followed by the second pipe, installation of the berm, and continuous high dunes in an effort to completely fix the flood problem in the area. Mr. Suozzi asked for clarification of the status of the second pipe. Mayor Naughton responded noting that there is a \$2 million grant from US Fish and Wildlife, there is hope to get \$1 million in Open Space funding from the county, and the Borough hopes to sell the three (3) properties discussed earlier so the Borough can contribute to the overall funding without bonding money. Mr. Suozzi asked about cost estimates in connection with Mr. Avakian's current redesign. Mr. Avakian stated that the latest estimates reduce the overall cost by \$500,000 and brings the Borough very close to an overall estimated cost of \$4 million. Mr. Judge clarified that this refined estimate is not based upon a redesign so much as it is a revised estimate based upon obtaining more accurate data. Mr. Avakian confirmed. In connection with permitting, the Mayor added that since US Fish and Wildlife are spearheading the project they can go for a federal consistency permit and they are quite confident they can get the permits they need to get the project going.

Harry Zarb, 2205 Third Avenue, asked if the ownership question in connection with the pipe at Lake Como has been resolved. Mr. Dempsey stated that the Attorney General believes that it's Spring Lake's pipe. The Mayor added that if FEMA determines that the repair is an emergency repair then the Borough would be eligible for the 90% reimbursement of costs associated with the repair. Further, the Mayor stated, there is an agreement between Lake Como, Belmar and Spring Lake that the three towns would share the remaining 10% cost. Mr. Zarb stated that at times it's difficult to hear the comments at the meetings.
