

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7 OF THE BOROUGH CODE, "VEHICLES AND TRAFFIC", TO ADD ADDITIONAL PARKING SPACES RESERVED FOR PHYSICALLY HANDICAPPED PERSONS ON OCEAN AVENUE AND IN MARUCCI PARK IN THE BOROUGH OF SPRING LAKE**

WHEREAS, Chapter 7, "Vehicles and Traffic" sets forth the regulations within the Borough of Spring Lake regarding parking and traffic within the Borough; and

WHEREAS, Section 7-28 provides and authorizes locations for the placement of parking spaces reserved for physically handicapped persons pursuant to N.J.S.A. 39:4-197; and

NOW, THEREFORE, BE IT HEREBY ORDAINED, by the Mayor and Borough Council of the Borough of Spring Lake, in the County of Monmouth and State of New Jersey, that Chapter 7, "Vehicles and Traffic", "§ 7-28. Parking reserved for physically handicapped persons", is amended in its entirety to read as follows:

**Section 1.**

**Section 2.**

If any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

**Section 3.**

Any ordinances or parts thereof in conflict with the provisions of the Ordinance are repealed to the extent of such conflict; and

**Section 4.**


This ordinance shall take effect on upon passage and publication in accordance with applicable law.
