#### **Proclamations, Presentations & Special Guests**

Proclamation – Mental Illness Awareness Week – May 5-11, 2015

The Mayor stated that the Woman's Club of Spring Lake is specifically supporting Mental Illness Awareness Week. The Mayor asked that the following proclamation be placed into the record.

Proclamation - MENTAL HEALTH MONTH - MAY 2015

WHEREAS, mental health is defined as emotional and psychological well-being, which allows individuals to work, enjoy satisfying relationships and participate fully in their communities; and

WHEREAS, approximately 25 percent of people experience a diagnosable mental health condition in their lifetime; and

WHEREAS, mental illness accounts for four of the top ten leading causes of disability; and

WHEREAS, studies show that mental health is a significant component of physical health; and

WHEREAS, studies have shown that every dollar invested in evidence-based treatment yields \$2 to \$10 in savings from lost productivity as well as health, criminal justice and other costs; and

WHEREAS, when offered adequate services, wellness and recovery are possible for all who live with mental illness; and

WHEREAS, mental health awareness, prevention and education encourage individuals to seek professional and/or social support; and

WHEREAS, the New Jersey State Federation of Woman's Clubs and the National Alliance on Mental Illness of NJ are working together to raise awareness about the importance of mental health and to advance treatment opportunities for individuals with mental illness; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Spring Lake do hereby proclaim May 2015 as Mental Health Month.

#### **Public Comments**

Harry Zarb, 2205 Third Avenue, asked if the status of the Borough website will be addressed during the meeting. The Mayor asked Municipal Clerk Jane Marban to give an update. Mrs. Marban reported that it's nearing completion and she hopes to have Deputy Clerk, Dina Zahorsky, attend the next meeting to provide a presentation on the new site. The Mayor added that she's been involved in the project as well and stated that the site looks great. Ms. Marban added that Community Pass will remain the primary site for the sale of beach badges and enrollment in activities but the new website will allow for the Borough to eventually collect taxes and water/sewer payments online. Mr. Zarb asked what the target date is for going live. Mrs. Marban stated that they hope to have it ready by June 1, 2015.

#### **Council Comments & Staff Reports**

Mayor Naughton reported that the Borough received a \$150,000 grant from the Department of Transportation in connection with the application submitted for Second Avenue road repair near St. Catharine School.

In addition, the Mayor reported, the Borough received one of two of the permits needed for the pipe at Wreck Pond.

The Mayor further reported that the application for the grant in connection with Wreck Pond has been received and is being reviewed and scored. The Borough hopes to hear something in response to the application within the next couple of weeks, stated the Mayor.

Mr. Avakian added that he believes the Borough may get a response to the application by May 7, 2015.

The Mayor brought attention to the new plantings at the entrance to the Borough on Ocean Avenue by the arches stating that it looks quite nice. The Mayor commented that this area is one of the last areas in the Borough being addressed that suffered damage from Superstorm Sandy.

The Mayor stated that there has historically been a great deal of comments and discussion regarding the use of leaf blowers in the Borough yet there's never been any action taken regarding restrictions. The Mayor asked the council to consider adding to the construction noise ordinance, that's currently in place for the three (3) months of summer, a ban on the use of leaf blowers on the weekends.

In addition, the Mayor continued, Mr. Frank Phillips, Superintendent of Public Works, raised the issue of an increasing problem of debris being blown into the streets year round. As a result, the Department of Public Works (DPW) is deploying manpower and equipment year round, versus on the scheduled brush pick up days, to clean up the streets. One suggestion, the Mayor stated, is to ask landscapers that work in the Borough to register their business and the properties they service with the Borough. There would be no fee and it's not intended to be anti-landscaper but more a means to improve communication, stated the Mayor, adding that the landscapers may not realize which dates the DPW picks up brush or that debris cannot be blown into storm drains. The Mayor stated that she believes it will improve communication and be mutually beneficial for the Borough and the contractors who work in the Borough.

Mr. Frost added that he has received several emails from residents on this topic and agrees that it's time to look how landscapers operate in the Borough. Mr. Frost voiced agreement with the restriction of the use of leaf blowers on weekends as well as the landscaper registration citing that in addition to the reasons the Mayor spoke of there's also a safety component of knowing who's working in town.

The Mayor added that there would be an exception made for those residents who do their own lawn citing the potential scenario of a homeowner who works during the week and only has the weekend to do their lawn.

Mr. Judge agreed with the commercial landscaper ban and agreed that it should not be applied to the residents. As for the registration component, Mr. Judge stated he would need to consider this further.

Mrs. Venables voiced agreement and added that she would also consider supporting a ban on leaf blower use after 4:00 pm on weekdays as well noting that this may be reasonable given that other towns ban their use altogether.

Mr. Harry Zarb, 2205 Third Avenue, suggested the council keep in mind this may negatively impact residents by increasing the cost residents have to pay for their commercial landscapers.

Mr. Judge reported on behalf of the beach committee that they will be offering a paddle box that will allow for the storage of paddle and surf boards. Mr. Judges stated that they will be built by the DPW, and there will be a total of twelve (12) offered: four (4) at Atlantic Avenue, four (4) at Washington Avenue and four (4) at Remsen Avenue. The fee, Mr. Judge added, will be \$500 for a period of one year. These will be available to residents on a first come, first serve basis, stated Mr. Judge, adding that if it's a successful program they may consider more in the future.

Mr. Frost, also on behalf of the beach committee, reported that they are exploring the possibility of having a pre-season, informal meeting for resident pool users to share ideas and thoughts. Details on the date and time of the meeting will be announced soon.

Mrs. Venables congratulated the Historical Society on their recent exhibit opening. Also, Mrs. Venables reminded everyone of the Arbor Day Ceremony in Potter Park being held tomorrow.

Mr. Frost added that he attended the Historical Society's opening and stated that it was very good and stated that the entire museum is quite amazing.

Mrs. Venables also expressed thanks to the Department of Public Works (DPW) for the landscaping work done at the arches stating that they did a beautiful job. Mrs. Venables added that to their credit they received an estimate to outsource the work, since they are quite busy, but it was quite costly and as a result the DPW decided to do it themselves thus saving the Borough quite a bit of money.

#### **Borough Engineer's Report**

Mr. Avakian reported that contractor Mark Woszczak has completed the water system improvements in the Wreck Pond watershed and is now working on the sanitary sewer improvements. When the sanitary sewer improvements are complete, approximately the second week in May, the contractor will begin the utility work on Ludlow Avenue, stated Mr. Avakian.

Regarding the recent US Fish and Wildlife meeting, Mr. Avakian reported that it was very productive and the project is on track with the initial timeline. Mr. Avakian stated that there are two (2) pending issues that need to be addressed before the timing of the bid schedule is obtained. The first being the permitting from DEP which the Borough expects in May and once received the Borough can go out to bid if funding is in place, stated Mr. Avakian. Another item that has recently been completed, stated Mr. Avakian, is the installation of four soil borings

Mr. Judge asked what the cement pipes located in the Pier Beach parking lot were for. Mr. Dempsey responded that they are for the Wreck Pond project.

Mr. Marlowe, 110 Pennsylvania Avenue, suggested the Borough continue to seek out other funding sources if the funding is not obtained from the DEP.

- 8. The agreement shall be immediately terminable at the option of the Borough if the same is deemed to be in the interest of the public health, safety and welfare.
- All boats will be removed from the Spring Lake beach at the end of the beach season, no later than the
  date determined by the Borough, which date will be communicated to the Club to provide at least two
  weeks' notice.

#### **Public Comments**

Lyle Marlowe, 110 Pennsylvania Avenue, asked if The Bridge Newsletter is going to continue. The Mayor stated that although it has not been published as frequently as in the past, the Borough has tried to send out periodic topic specific letters from time to time. The Mayor also noted that the new website will also be an, albeit more passive, resource for Borough information and news.

Mr. Marlowe also voiced concern about the upcoming road closure at Ocean Road and suggested the Police Chief be alerted to potential concerns. The Mayor stated that the road will be signed and block well in advance of the railroad tracks. The Mayor stated that she will certainly speak with the Chief.

Mr. Marlowe also brought attention to the fact that the "No Parking" signs have been removed on Ocean Road in anticipation of the work and people have begun to park on both sides. Again, the Mayor agreed to reach out to the Chief.

Elsie Dubac, 415 St. Clair Avenue, in connection with the infrared paving, asked if the gas company is using this method with the paving that they're doing. The Mayor responded stating that Mr. Dempsey has an agreement with the gas company and others that if the road being opened is not scheduled to be paved in the next year or two the company would need to return and use the infrared paving. For roads that are scheduled to be milled and paved in the near future the company doing the work will give the Borough an agreed upon dollar amount toward the future infrared paving, stated the Mayor.

Ms. Dubac asked about asphalt that was used on the sidewalk on Fifth Avenue. Mr. Dempsey stated that on occasion they will use asphalt on the sidewalk for safety purposes while the work is settling and then return at a later date and replace the asphalt with concrete.

Ms. Dubac asked if the Borough has determined which streets will be done and when. The Mayor reported that a study was done that identified which roads need to be done but the Borough is awaiting the final results of the water study that's being done so as to avoid paving a road only to discover the underlying infrastructure needs to be repaired. The plan, the Mayor continued, is to marry the two studies together and budget the projects in a coordinated fashion. The water study should be available to the Borough in June, added the Mayor. Mr. Frost added that the study will include a rating of the roads from best to worst to help with the prioritization.
