Council Comments & Staff Reports

Mayor Naughton reminded the council and public that Ms. Eleanor Twomey, a long-time resident of Spring Lake, left in her estate two (2) scholarships for female students and asked that the Borough consider and select the candidates. The Mayor reported that she and Mrs. Venables recently met to discuss the selection criteria for the scholarships. Mayor Naughton stated that in the next week or so they hope to have the criteria finalized and will report back on the topic. The Mayor added that the scholarships will be \$2,000 each and will be for students attending a community or a four year college and they will be available for students entering college or already enrolled.

Mr. Erbe reported that he recently read approximately half of the personnel manual and stated that he will be working with Mr. Dempsey on the document. Mr. Erbe welcomed comments and suggestions from the other council members.

Mr. Judge, on behalf of the beach committee, urged residents who have not yet purchased their lockers or beach boxes to do so by March 15th noting that the locker or box may be lost to a sponsored nonresident if they don't act by the 15th.

Mr. Marlowe reported that he had difficulties on the website and expressed concern that people who wait until the weekend may need assistance. Mr. Judge stated that if they do have difficulties and need in-person assistance on Monday the 16th, Borough personnel will be available to assist and they won't be at risk of losing their locker or box. Mrs. Marban added that an email has been sent to those residents who have not yet paid that offers clarification on how to easily submit payment noting that this level of detail was not included in the first letter. This, Ms. Marban added, should minimize any additional confusion.

Borough Engineer's Report

Mr. Avakian, referencing the bond ordinance on the agenda, stated that the plans for the Ludlow Avenue project are complete and ready to go. Further, Mr. Avakian reported that they are prepared to move forward with plans and permits in connection with Wreck Pond and the outflow pipe and the resiliency grant application.

Also, Mr. Dempsey reported that work has begun on the additional restrooms at pier beach which result in two (2) additional sets of restrooms at this location.

Mr. Dempsey further reported that the Borough has received a \$130,000 grant for the living shoreline.

Regarding the arches at the north end of town, Mr. Dempsey reported that he and Don Brahn, Jr. met with landscaper Mike Burke to discuss the concept plan. Mr. Burke offered a schematic and will provide pricing at a later date, stated Mr. Dempsey, with a goal to get the work complete by the summer. Mayor Naughton, for the benefit of the public, stated that the plan is to put in place plantings that are salt and wind resistant, to the extent possible, and will not need on-going irrigation. Mr. Dempsey added that there will be some irrigation needed initially until such time that the plants take root. Mr. Frost asked if they also looked at the SMRSA Plant in connection with the plantings planned for this area. Mr. Dempsey confirmed that he did. Mr. Frost also suggested that Mr. Burke review the area north of the north pavilion. Mr. Dempsey agreed to have this looked at. Mr. Dempsey reported that the pump station located at Pitney Avenue has been knocked down and they are working daily to get the work completed by summer.
