Council President Judge called the Regular Meeting of the Mayor and Council of the Borough of Spring Lake to order at 7:02 P.M. with a moment of silent prayer. He then proceeded with the Pledge of Allegiance to the Flag. Council President Judge announced that the meeting is being held in accordance with the Open Public Meetings Act.

Proclamations, Presentations & Special Guests:

Council President Judge introduced James Wingard who will be beginning his Eagle Scout Project in Devine Park. Mr. Wingard's project consists of two parts, the first being the restorations of a portion of the trail around the lake near the playground. Currently the area is overgrown with weeds and thorn bushes; he will be planting new plants which will be watered by the already existing sprinkler system. The second part of the project will be the building of a new fire pit around the already existing stone circle; it will be five feet in diameter.

Mr. Judge asked about the previous Eagle Scout Project completed by Matthew Hale and where this project will be located in relation to Mr. Hale's. Mr. Wingard used a map to show where his projects will be taking place. Mr. Wingard will be using volunteers from his troop along with friends and family to complete the project.

Mr. Judge asked about the current use of the fire pit located on the path. Mr. Dempsey said he has only seen it used during the winter months when the lake freezes over.

Ms. Whalley asked if the new fire pit will be flush with the ground. Mr. Wingard explained it will go around the perimeter of the existing fire pit. Mr. Dempsey added that this new design will be safer. Mr. Judge asked how Mr. Wingard determined what kind of plants he will be planting. Mr. Wingard explained they are the same plants Matthew Hale used in his project to keep the same look as the previous project.

Mr. Frost asked if there is any intention to clean up the area around the fire pit. Mr. Wingard said it wasn't planned with this project.

Mr. Sagui asked if there will be any mulch. Mr. Wingard said yes.

Mr. Judge asked about the timing of the project. Mr. Wingard indicated they plan to begin work around August 19 and 20th.

Mr. Frost offered a motion to approve the project seconded by Ms. Whalley.

Public Comments:

Elsie Dubac, 415 St. Clair Avenue asked for R-17-140 Phase III to be explained. Mr. Dempsey explained it is the last phase of the Third Avenue project from Lake Como to Pitney Avenue. Ms. Dubac asked if it will include pavers. Mr. Dempsey indicated it will not include any pavers but will include crosswalks similar to the crosswalks at Pitney Avenue.

Mr. Dempsey used this as an opportunity to discuss the possibility of a traffic calming device along Third Avenue. He explained that a traffic table has been proposed, which is not a speed bump but more of an incline about twenty two feet long, it has been proposed to have two of them in this section of town; they will be similar to the ones on Jumping Brook Road in Neptune.

Mr. Frost explained it will be a gradual incline that makes you slow down.

Mr. Avakian added it will be going out to bid soon so they can award the contract in September. Ms. Whalley asked if the idea of a median is off the table. Mr. Frost explained it is not off the table, the goal is to narrow the road without a median since they can be costly. Mr. Dempsey added the issue with the median is that they have not found a median design that anyone likes, which is why the speed tables came up.

Ms. Whalley explained that if you google traffic calming medians, there are beautiful medians that contain small bushes and trees that are six feet wide that are low maintenance.

Mr. Judge added that they are exploring ideas and the possibility of adding a median in the future is a possibility.

Harry Zarb, 2205 Third Avenue brought up the issue of bicycles and lack of enforcement of any rules regarding bicycles. He feels there are plenty of special police officers in the downtown area and suggested the specials enforce bicycle discipline. Mr. Frost agrees with his assessment of children on bikes, they ride in the middle of the road without helmets on their cell phones.

Mr. Judge will bring it to Chief Kerr's attention.

Lisa Deberadine, 10 Brown Avenue added that cyclists think they are pedestrians. Mr. Sagui pointed out that if it has wheels they are to abide by car laws.

Ms. Whalley suggested providing water and bicycle safety with the help of the police department in the schools. Rich Clayton, Third Avenue added that bicycles are a daily issue downtown.

Mr. Judge asked if he sees the police special officers warning the bicyclists or if they avoid them. Mr. Clayton said they police special officers do not say anything to them about riding on the sidewalk.

Mr. Dempsey received a phone call today about bicyclists riding on Third Avenue, in the street, and concern about someone getting hit since the road is so tight. Mr. Judge will reach out to the public safety committee to discuss this concern.

Ms. Whalley asked Chief Kerr about using parking spaces for bicycle racks, which he was completely against, stating it is unsafe. Ms. Whalley is looking at getting more three foot bike racks for next summer for along Third Avenue.

Council Comments & Staff Reports:

Mr. Judge reported there has been a request from the Recreation Director for cameras at Marucci Park. Mr. Dempsey discussed with the Mayor and asked if they can hold off on discussing cameras until next meeting when the she is present.

Mr. Frost discussed road projects that will be completed this fall, which Mr. Avakian will add to. The roads committee is also working on a long range plan for the future. Mr. Avakian indicated the next project they will be going out to bid on will be Third Avenue Phase III from Pitney Avenue to Lake Como. He added that the design is almost completed the traffic calming with include a minimum of two speed platforms which will be twenty two feet in length including a flat area spanning ten feet, which rises on both sides. As drivers pass over the platform, if they are going the speed limit they will feel the gradual rise of the road, however if a driver is speeding they will feel a jolt, not like a speed bump, but it is intended to warn the driver that they are speeding. Mr. Frost added that there will be proper signage to warn the drivers of the plat form. Mr. Avakian explained that speed platforms are allowed on roads where the speed limit is less than thirty five miles per hour and there are less than three thousand vehicles on the road. He added that the speed table will be complimentary to emergency vehicles and snow plows. Mr. Avakian also pointed out that drainage improvements will also be a part of this project at the driveway of Marucci Park; curbing and sidewalks will be replaced from Monroe Avenue to South Boulevard. Mr. Dempsey added that when residents are notified of the work, there will be pricing made available to them to repair their sidewalks. Mr. Avakian added that this work will be complimentary to the work Frank Miksovich completed regarding the traffic study. Ms. Whalley asked about the possibility of laying utility lines underground. Mr. Avakian explained that it would be installed through a conduit; these types of conduits would be placed in the center line of the roadway.

Mr. Avakian continued with the sewer project contract being awarded for South Boulevard between Third and Fourth Avenues; the work will be beginning immediately. Once that work is completed South Boulevard will be paved from Monroe to Third Avenue and from Third Avenue to almost Fourth Avenue. Mr. Dempsey explained Monroe to Third Avenue paving will be a part of the Third Avenue project while the paving of South Boulevard to Fourth Avenue will be completed next year.

Mr. Dempsey added they are looking at micro-surfacing Morris Avenue; it is better to wait until the fall when there is less traffic to start. He is also looking from Prospect to Pitney Avenues and onward to Monroe Avenue. Mr. Dempsey suggested looking into utilizing the County for paving jobs. He indicated there are a couple areas on St. Clair that the gas company paved so it would be wise to mill the remaining section and pave between Fourth and Fifth Avenues.

Ms. Whalley asked if the micro-surfacing will be done before the Irish Festival in the fall. Mr. Dempsey answered yes and added that they will also crack seal Third Avenue from Passaic to the Community House as well.

Mr. Frost thanked the BID (Business Improvement District) and Mr. Dempsey for the American Flags which were used for the funeral of a local Marine from Colts Neck; the mother of the Marine taught at St. Catharine's School for quite some time. He added that a total of forty flags were collected to use.

Mr. Sagui asked where the borough stands on the water main loop right now. Mr. Dempsey indicated that Atlantic Avenue is out to bid and critical valves and hydrants will be out to bid within the next two weeks and will be awarded at the second meeting in September. The Atlantic Avenue

contract will be awarded at the first meeting in September. Mr. Avakian explained that the next job going out to bid will be the painting of the water tower.

Mr. Dempsey continued that a new four hundred foot water line has been added between Passaic and Warren Avenues along the railroad tracks, which was a part of the Ludlow Project; there has been a continuous rust issue in this area and the looping of the water main should help. Mr. Sagui added there has been a lot of standing water at Warren and Ocean Avenues. Mr. Dempsey added there is also pooling water at Morris and First Avenues which needs to be looked at.

Ms. Whalley reported the BID held three ribbon cutting ceremonies for new businesses in town. Next week on August 16th the BID and Chamber of Commerce are hosting a benefit performance of the Music Man at the Community House.

Ms. Whalley reported that the library opened their new art exhibit which will be open for the next few weeks.

Ms. Whalley further reported that the Board of Education is scheduled to have their demographic study at their August 21st meeting at H.W. Mountz Elementary School starting at 6:30 pm. She added the school is in the process of putting up a new chain link fence as part of their beautification plan and the Public Works helped with the removal of trees and tree stumps to make sure the fence is level.

Borough Engineer's Report:

Mr. Avakian pointed out one item on the agenda tonight is the Lorraine and Tuttle Avenue water improvement, which includes water main updates and system looping on both of those roads; it is an expensive project costing 1.5 million dollars. He added that this will complete the Ocean Avenue project and looping system. He received a proposal from H2M, Pat Cole, and will use their design to go out to bid; once bids are received Mr. Avakians office will make a recommendation for award and will oversee construction. Mr. Avakian added this will be completed over the winter by Memorial Day weekend, meaning it needs to go out to bid before the end of this year.

Borough Attorney's Report:

Mr. Colao has one item for executive session.

Borough Administrator's Report:

Mr. Dempsey reported the 2018 Transportation Trust Fund application has come out; they have to decide on a road and submit an application. Typically they like roads that connect their roads or county roads; in the past they got Ludlow Avenue, Newark Avenue, Jersey Avenue, and South Blvd. Mr. Dempsey will meet with the streets and roads committee before the deadline to come up with a road to apply for.

Mr. Dempsey reported that the BID asked about music downtown during different times of the year through a sound system; the speakers would be paid for by the BID and would be controlled by the BID as to what type of music and when it would be played.

Rich Clayton, Third Avenue added that it would be strictly music played and not advertisements and the system would contain wireless speakers which would be put out during specific times. Mr. Clayton added the project would be done in two to three phases. They would play classic music and stager the speakers and try it block by block. Music would be played during special events and certain times of the year.

Elsie Dubac, 415 St. Clair Avenue asked how residents in apartments above downtown would feel about music playing. Mr. Sagui and Mr. Clayton both added that the music is soft and not loud, apartments may not even hear the music. Ms. Whalley explained that the music wouldn't be played every day and would only be played during business hours.

Mr. Dempsey further reported that a few months ago Mayor Naughton sent a letter to Lake Como concerning their First Aid calls; Belmar is working on a solution and the number of calls to Lake Como has dropped off.
