### **Council Comments & Staff Reports:**

Mayor Naughton congratulated everyone involved with the Spring Lake 5 this past week and the children's race, it was an enormous success and a lot of fun. She had the opportunity to go downtown to the sidewalk sale and go to the beer tent. She hopes it was a successful weekend for the downtown area.

Mayor Naughton continued that the Memorial Day Ceremony was beautiful and thanked James Lonesdale, Kathy Heine, the Department of Public Works, and the Fire Department for their help in putting the event together.

Harry Zarb, 2205 Third Avenue gave a special thanks to whoever arranged the fly by.

Mr. Erbe reminded the Council and public that the Ocean Mile Swim will be on July 13th.

Mr. Erbe continued that in two weeks there will be a public hearing on the budget, which is available to be viewed at Borough Hall.

Mr. Frost reported that the Memorial Day Ceremony was amazing and said that Kathy Heine won't be able to top it.

Ms. Whalley thanked everyone for the fabulous weekend.

She thanked Mr. Dempsey and Frank Phillips who were there from 7:00 am to 3:00 pm for their help with the beer garden.

She continued that Morris Avenue looks great and the contractors are doing a nice job.

Ms. Whalley then reported that Parks and Recreation are waiting to hear back from Mr. Avakian's team regarding the Divine Park Open Space Grant because they would like to get moving on Phase III which covers the bank stabilization and nature trail. Mr. Avakian explained that that they have a couple of years to complete the work with this grant. Ms. Whalley added that they have some time to put together their application for the next Open Space Grant but need to figure out the cost and scope of the work for this year's grant, before deciding on what needs to be done next year. She continued that the next Open Space Grant is out but isn't due until September for 2020. Mr. Avakian wants to get the project design complete and bid at the end of August and begin construction in the fall for the current Open Space Grant project.

## **Borough Engineer's Report:**

Mr. Avakian reported that the concrete curbing, pavers, and island are complete on Morris Avenue. They are waiting for an underground storage tank to be removed before they start paving. Mayor Naughton asked how long it takes to get a permit to remove the tank. Mr. Dempsey explained that the tank is unregistered and abandoned. Mr. Avakian explained that if it disturbs an existing structure, they can leave the tank and fill it, but if it has no effect on a building, the tank is to be removed. Mr. Dempsey thinks it may be a gasoline tank, since a gas station used to be there.

Mr. Avakian continued that Fernandes is going to begin milling Fourth Avenue, Villa Park Way, and Fifth Avenue next week, followed by paving but as of right now, the underground storage tank is not holding up the paving of Fifth Avenue.

Mr. Avakian then reported that the Pitney Avenue sewer lining project is bringing in another crew next week to do the connections between the lateral and the main. As of right now they are about sixty percent complete.

**Borough Attorney's Report:** 

Mr. Colao does not have anything tonight for closed session but wanted to follow up on an email he sent out earlier regarding the small cell equipment issue. He sent a picture of what the nodes look like in Asbury Park and stressed that they cannot do anything that prohibits their erection. Mayor Naughton explained that there is another piece of the node that is located at the bottom of the pole. She continued that there are some communities that have been able to get around this. Mr. Colao thinks they may have done so through negotiation.

Mayor Naughton explained that for an upgrade for 5G telecommunications requires small cells located closer together, rather than having antennas on the water tower and at the pavilions. She said they are located in front of residential homes and the impact is not, in her opinion, insignificant. She is worried about how this will be handled.

Mr. Judge explained that this has been ordered by the FCC so they are trying to prepare an ordinance to try and limit the change.

Mr. Drasheff added that this isn't just Ocean Avenue that would have the nodes, but the entire town. Ms. Whalley asked how close they would be. Mr. Sagui explained they would be anywhere between two hundred and five hundred feet apart.

Mr. Sagui asked if they can include in the ordinance that they take down old technology before replacing with new technology.

Lyle Marlowe, 110 Pennsylvania Avenue asked if they will receive an income from the 5G poles. Mr. Dempsey explained they would receive a minimal fee, about \$75.00 per pole. Mr. Marlowe asked if they will get rid of the cell towers. Mr. Dempsey indicated no. Mr. Sagui added that maybe they will be removed when 5G takes over.

Mayor Naughton asked if there will be an ordinance in the upcoming weeks that will be introduced for this. Mr. Colao would like to see an ordinance in about a month.

### **Borough Administrator's Report:**

Mr. Dempsey reported that Fernandes is going to start curb work on Passaic Avenue tomorrow and hopefully have it completed within the next day or so. They are also looking to put some sort of base work down by Friday and begin Tuttle Avenue from the railroad tracks to Fifth Avenue, then towards the beach front. They are hoping to have Tuttle complete by the end of the summer for the school year. After the curbing is complete, they will come back and pave, which is expected to be complete within the next two weeks.

Mr. Frost asked if they are contacting the homeowners on the street for sidewalks. Mr. Dempsey indicated that they are.

Mr. Dempsey continued that the landscaping at public works has been planted and they finished the landscaping at Marucci Park.

He then reported that the cameras are ninety five percent done and they will be putting a few on Third Avenue that are not done yet but the cameras at public works, train station, the arches, and the pavilions are all done. They do have a policy complete. The license plate reader has been

installed and is being used. Mr. Dempsey indicated that they have a policy in place and only certain people may use the cameras and for specific reasons. He will get the policy for the Council.

Mayor Naughton explained that they are not a live feed camera, but rather a camera to record in the case that there is a crime.

Mr. Dempsey continued that the South End bid specs will hopefully be done this week. They will be advertising and going out to bid this week. They will allow four weeks to receive bids and hopefully award a contract either the first or second week of July.

Mr. Dempsey reported that Dan Finn had a stroke and is doing well but the staff has stepped up and had a great Memorial Day Weekend without any issues. Kevin Olberto, Mark Jarmon, and the rest of the staff is doing a great job.

A. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Borough Council of the Borough of Spring Lake in the County of Monmouth finds it advisable and necessary to increase its CY 2019 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the governing body hereby determines that a 3.5% increase in the budget for said year, amounting to \$256,403.48 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Spring Lake, in the County of Monmouth, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2019 budget year, the final appropriations of the Borough of Spring Lake shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5%, amounting to \$256,403.48, and that the CY 2019 municipal budget for the Borough of Spring Lake be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Ms. Whalley explained that this has become worse because Sea Girt has since changed their ordinance for drop offs at the Parker House.

#### **Public Comments:**

Mike Grzelak, 409 Monmouth Avenue asked if there is any expectation of the Spring Lake Five growing any larger than a race with 12,500 runners. Mayor Naughton said there has not been any request for the race to grow any larger, and isn't sure the course could handle a larger race. Mr. Judge relies on the common sense of the race committee that wouldn't allow the race to grow too large. Mr. Dempsey indicated that 12,500 is the limit of runner permitted, and they have come nowhere near that number of finishers. They only have about 10,000-11,000 runners that actually finish. Mayor Naughton added that this year they had 10,400 finishers.

Mr. Erbe added that he made this comment years ago when the race of 6,000-7,000 runners. The only issues he sees is the start, when everyone is jammed together, and need to be careful during the start.

Mr. Frost added that they do negotiate a contract with the Spring Lake Five Race committee every three or four years, which is when they make the decision on how many runners are permitted. He continued that they try their best to make sure it's controlled with added security but they have no intention to limit the race or grow it.
